I. LEGISLATIVE INTENT: It is the intent of the Town Board of the Town of Russell, to pass a local law pursuant to Real Property Tax Law §467 in order to provide an exemption for persons 65 years of age or over who have certain income levels with regards to their real property tax. It is the intent of the Town Board to take into account the situation of those citizens who earn certain incomes and being of such an age that most of their income is probably on a fixed income basis.

II. TEXT OF LAW: The maximum income exemption eligibility level pursuant to §467 of the Real Property Tax Law for the Town of Russell shall be established as \$7,000.00 with a fifty percent assessment reduction.

III. EFFECTIVE DATE: This legislation will become effective upon the passage of the Town Board of The Town of Russell and filing with the Secretary of State.




